

Healthy Football League: T&C

Terms and Conditions v1.0 20-03-2020

The Healthy Football League App and its related services (from now on referred to as the 'Services') are made available to you by 'Stichting European Football for Development Network' (from now on referred to as EFDN) with its address at Takkebijsters 9A-11, Breda, 4817 BL, The Netherlands. These Services are offered to you based on the terms and conditions, outlined in this document, and EFDN's Privacy Policy, which outlines how we collect and use your personal information.

By clicking on the GET STARTED button, using or accessing our Services, or by giving your assent to these terms, YOU ARE AGREEING TO THESE TERMS. If you DO NOT AGREE to these terms, then you should not access or make use of the Services provided by EFDN.

These terms and conditions may be amended, and you will be notified if any changes are made. You will need to agree to the updated Terms and Conditions, before you will be able to use the Services again.

If you make use of our Services on behalf of an organisation/company or other body, you indicate that you have the authority to bind this entity to the terms and conditions outlined in this document. If you do not have this power, then you do not have the right to access these Services on behalf of your organisation.
